9 **THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER**
10 **WATCHING THE HEARING ONLINE, LISTENING TO THE HEARING VIA**
11 **TELEPHONE, OR ATTENDING IN PERSON.** At least 24 hours in advance of the
12 hearing, information regarding online and telephone hearing access, as well as any additional
13 details regarding safety protocols or other revisions to the hearing schedule will be noticed
14 on the Project website at <https://projectbaccara.com>.

15 The Chairman may, at his discretion, recess the hearing to a time and place to be
16 announced during the hearing, or to be determined after the recess. The date, time and place
17 at which the hearing will be resumed will be posted on the above-noted Project website and
18 the ACC website. **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE**
19 **GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH RESUMED HEARING IS**
20 **NOT REQUIRED.**

21 If the Committee decides to conduct a tour, notice that includes a map and itinerary
22 of any such tour will be available at the hearing and posted on the Project and ACC websites.
23 Members of the public may follow the Committee on the tour. During the tour, the
24 Committee may hear testimony at stops concerning elements of the Project. No other
25 discussion or deliberation concerning the Application will occur during the tour. A court
26 reporter or recording device will record any testimony taken on the tour for transcription.

1 Public health and safety protocols specific to the tour will be included on the itinerary. If the
2 Committee decides not to take a tour, the hearing will continue as scheduled.

11 The Applicant will make available final copies of the pre-filing conference, pre-
12 hearing conference, and evidentiary hearing transcripts at each of the above locations and
13 Project website.

14 Each county and municipal government and state agency interested in the Project and
15 desiring to be a party to the proceedings shall, not less than ten (10) days before the date set
16 for hearing, file a Notice of Intent to Become a Party with the Director of Utilities, ACC,
17 1200 W. Washington St., Phoenix, AZ 85007.

18 Any domestic non-profit corporation or association formed in whole or in part to
19 promote conservation of natural beauty, to protect the environment, personal health or other
20 biological values, to preserve historical sites, to promote consumer interests, to represent
21 commercial and industrial groups, or to promote the orderly development of the area in
22 which the Project are to be located and desiring to become a party to the proceedings shall,
23 not less than ten (10) days before December 1, 2025, file a Notice of Intent to Become a
24 Party with the Director of Utilities, ACC, 1200 W. Washington St., Phoenix, AZ 85007.

25 The Committee may make other persons parties to the proceeding at any time. Any
26 person may make a limited appearance at a hearing by filing a statement in writing with the
27 Director of Utilities, ACC, 1200 W. Washington St., Phoenix, AZ 85007, not less than five

1 (5) days before the date set for hearing. A person making a limited appearance shall not be
2 a party or have the right to present testimony or cross-examine witnesses.

3 This proceeding is governed by Arizona Revised Statutes (“A.R.S.”) §§ 40-360 to
4 40-360.13 and Arizona Administrative Code R14-3-201 to R14-3-220. No substantive
5 communication not in the public record may be made to any member of the Committee. The
6 written decision of the Committee will be submitted to the ACC pursuant to A.R.S.§ 40-
7 360.07. Any person intending to be a party to the proceedings on these matters before the
8 ACC must be a party to the proceedings before the Committee.
